

## Club 8349 Membership Policy

### I. Members

A Club 8349 member is defined as an individual who has applied and has been accepted for membership into Club 8349 and pays their dues in full on an annual basis.

- All members of the Methuen Veterans of Foreign Wars (VFW) Post 8349 whose membership is in good standing are considered members of Club 8349
  - To apply for membership, an individual must have a sponsor. A sponsor, for the purposes of membership, is defined as a member of the Methuen VFW Post 8349 who membership is in good standing.
  - Upon acceptance for membership, a Club 8349 member will pay his/her first year dues in full and will be issued a membership card and a key card. Current dues are \$10.00 per person.
  - Subsequent club dues are due on the first day of June each year.
  - Club 8349 members will adhere to the club's policies and procedures as set forth by the Board of Directors (BOD).
  - Club 8349 members who are not members of the Methuen VFW Post 8349 in good standing may not hold a position on the BOD.
  - In the case of non-payment of dues, a member's membership will be suspended until the dues are paid in full. The Club Manager may at his/her discretion, deny entry as guest to any member whose dues are not paid up to date.
  - Club 8349 members whose membership has been terminated for misconduct will not be admitted as guests for a period to be determined by the Club Manager.
  - A person eligible for membership who does not wish to join the club will need to be signed in as a guest and/or will be welcome in the club on days specified as "Open" by the BOD.
  - The Manager of Club 8349 may deny entry to any Club 8349 member at his/her Discretion.

**II. Guests**

A guest is defined as an individual who is not a member of Club 8349.

- A guest must be sponsored by a member of Club 8349 and sign the guest book. The Club 8349 member must also sign the guest book as the sponsor in order for the guest to remain in the club.
- When the Club 8349 member leaves the club, the guest must resign the guest book provided another Club 8349 member will sponsor the guest. If no other Club 8349 member is willing to sponsor the guest, the guest must leave the club.
- Guest will adhere to the club's policies and procedures as set forth by the BOD.
- Guest are not permitted to bring visitors into the club.
- The Manager of Club 8349 may deny entry to any guest at his/her discretion.
